1 APOLOGIES FOR ABSENCE:

No apologies were received

2 MINUTES:

It was **RESOLVED** that the Minutes of the meeting held on **Tuesday 11**th **July 2018** be approved and signed.

Matters Arising:

Min 2 (Min 2) Drainage issues on footpath 9, adjacent to Leapers View. The Clerk had written to the two households concerned. Whilst the Clerk had not received any replies, action had been taken by one of the households to remove the downpipe causing water to drain onto the footpath.

Min 2 (Min 4(1)) Painting of kissing gates. ACTION: It was agreed that the Clerk should contact the City Council to ascertain whether this can be completed through the Community Payback scheme.

Min 2 (Min 4(8)) No parking signs, Top Green. This matter was now being considered by the City Council's Conservation and Planning Enforcement teams.

Min 2 (Min 4(9)) Damage to 'no cycling signs' alley to Church Bank. This had been referred to the Lengthsman, no conclusive update available at the time of the meeting.

Min 2 (Min 11) Contractors' work on the Village Green. The Chair advised that the Council was in negotiation with BT Openreach concerning their plans to install a new broadband chamber at the Village Green. The Council is pressing for the new chamber to be installed in the side road to the North-East side of the green.

Min 2 (Min 12) Parish Plan. The Parish Plan Group had met on 4th September to review the responses to the Parish Survey. An article on the outcomes is to be included in the October issue of OV View.

Min 4(1) Dangling brambles, etc on Footpath 9. The Clerk reported that this had been referred to the Lengthsman and had been attended to

Min 4(2) Gap in steps by the Chapel. The Clerk had referred this to the Lengthsman; no update available at the time of the meeting.

Min 4(3) Traffic queues and other issues, Capernwray Road. The Clerk had written to the Diving Centre about concerns raised by residents and had received a reply concluding that the Centre felt it was operating the best system possible. The Clerk was consulting the Community Police on their views regarding the current situation.

Min 4(8) Panorama Sign for Bay Croft. Councillor Agnew reported that the sign had been promised by the end of the month. The Lengthsman has worked to tidy up the Bay Croft site.

Min 7 Appointment of Bankers. Notice that the new bank account was open was expected in the next few days.

Min 8 Community Road Watch Scheme. An article had been included in the September issue of OK View. No volunteers had yet come forward.

Min 9 Touring Cinema. Further information on arrangements and likely costs had been provided by the Carnforth Town Clerk. The matter was now being referred to the Village Hall Committee for their consideration.

4 WYN PAVELYN AWARD 2018:

The Wyn Pavelyn Trophy for the best kept garden visible from a road or public footpath was awarded to Bob and Cath Escolme. The Chair presented the trophy to Mr Escolme, congratulated him and Mrs Escolme on the award and thanked the judges for their work. An article on the award is to be submitted for inclusion in OK View.

5 ADJOURNMENT FOR PUBLIC DISCUSSION & INFORMATION ONLY UPDATES:

Reports from members of the public:

- (1) Further concerns were raised about the safety of the roadside wall at the Eagles Head.

 ACTION: the Clerk to liaise with County Councillor Williamson in reporting the matter to the appropriate authorities.
- (2) A resident commented on potholes developing in the Eagles Head car park. It was advised that this was a matter to be raised directly with the owners.
- (3) Concerns were raised about the condition of the hedge along the footpath to Carnforth. **ACTION**: the Clerk to refer the matter to the County Council.
- (4) A recent traffic accident was reported on Capernwray Road, which had resulted in a vehicle colliding with a wall. The report was noted.

Volunteers to be sought to assist with the erection and dismantling of the marquee.

Associated with the Remembrance service, the Parish Council had received correspondence from the City Council inviting it to participate in two activities to mark the centenary of the end of WW1, namely the displaying of a 'Silent Soldier' silhouette and the lighting of a beacon on 11th November 2018. Following a discussion covering the costs and logistics of the activities, it was resolved not to participate.

9 CHRISTMAS TREE

The Chair outlined proposed arrangements for the installation of the Christmas Tree this year and sought views on the timescale.

RESOLVED: That the village Christmas Tree should be installed on Saturday, 8th December 2018 and taken down on Saturday, 5th January 2019.

10 CARAVAN NEAR RESTARIGG FARM

The Chair reported on a mobile-home style caravan that had recently appeared on the Kirkby Lonsdale Road skyline in the vicinity of Restarigg Farm. County Councillor Williamson advised that she had reported this to the City Council Planning Enforcement team, who had written requesting its removal. Councillor Williamson was prepared to follow this matter up should there be no action.
