

**THE LANCASHIRE COUNTY COUNCIL
(A601(M) ROUNDABOUT JUNCTION 35, A601M B6254 TO M6 JUNCTION 35, OVER
KELLET, LANCASTER CITY)(TEMPORARY SPEED RESTRICTION)(TEMPORARY
PROHIBITION OF STOPPING)(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019**

NOTICE IS HEREBY GIVEN that the Lancashire County Council have made an Order under **Section 14(1)(a) of the Road Traffic Regulation Act 1984**, as amended, the effect of which will be to temporarily prohibit any person to cause or permit any motor vehicle from proceeding at a speed exceeding 40 MPH over the following lengths of roads;

- I. A601M , Over Kellet, from its junction with B6254 Kellet Road, to its junction with M6 Junction 35 Roundabout
- II. M6 junction 35 roundabout, Over Kellet for its full circumference.

AND FURTHER, during the period of said restriction a prohibition of stopping will be implemented on the following lengths of roads

- I. A601(M), Over Kellet, from its junction with B6254 Kellet Road, to its junction with M6 Junction 35 Roundabout
- II. A601(M) Junction 35 Roundabout for its full circumference

AND FURTHER, during the period of the said restriction pedestrians, equestrians, cycles and horse drawn vehicles will be temporarily prohibited from proceeding over the following lengths of roads

- I. A601(M), Over Kellet, from its junction with B6254 Kellet Road, to its junction with M6 Junction 35 Roundabout
- II. A601(M) Junction 35 Roundabout for its full circumference

No speed limit imposed by this order applies to vehicles falling within regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when used in accordance with regulation 3(5) of those Regulations

The Police, Fire and Ambulance Services have been informed.

The temporary prohibition is necessary to allow development to be completed on land adjacent to the A601(M)

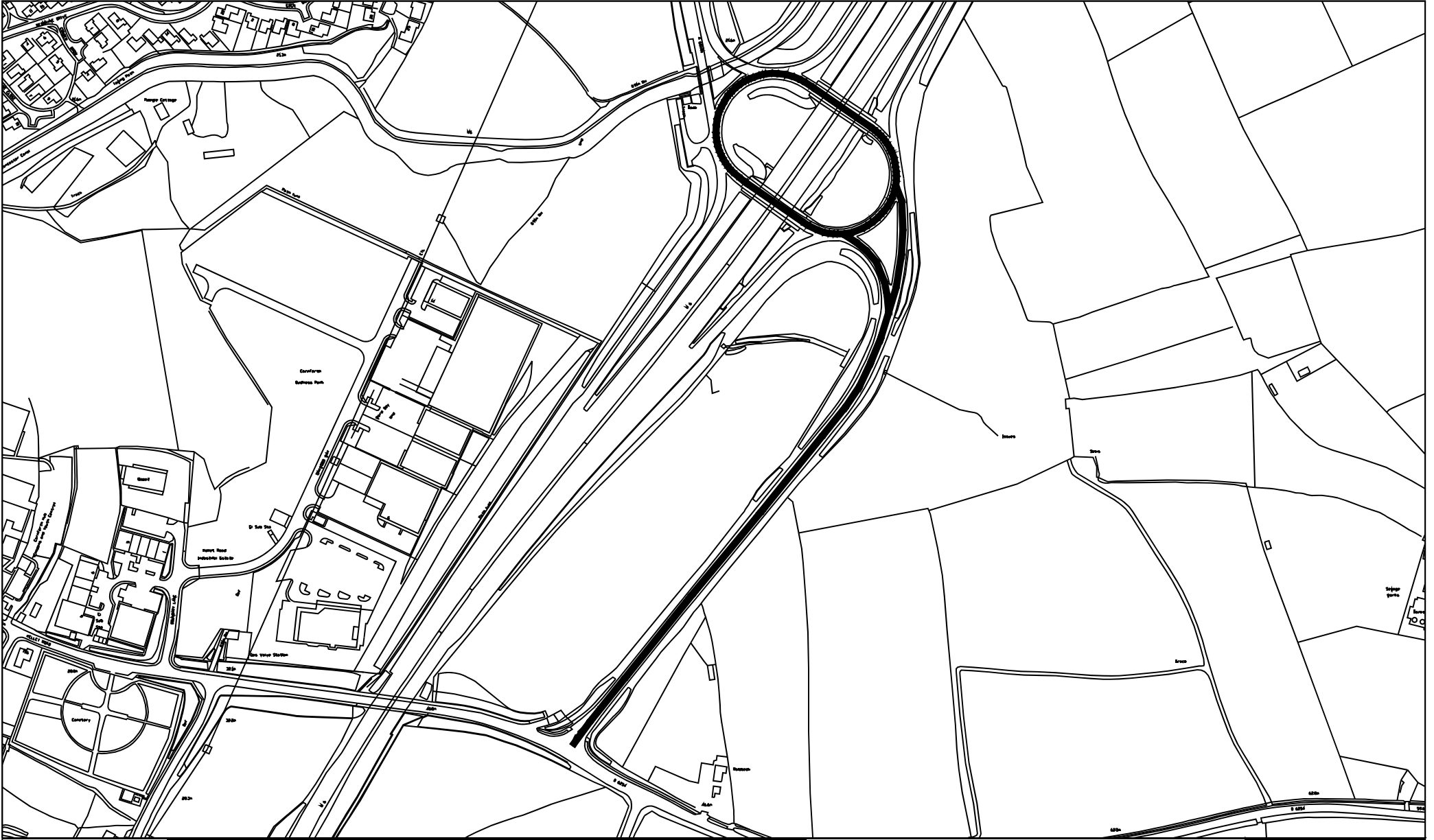
The prohibition will be operative from Friday 6th December 2019 until Friday 23rd April 2021.
