20/036 APOLOGIES FOR ABSENCE:

Apologies were received from Councillors Martin May and Stephen Atkins and County Councillor Phillippa Williamson..

20/037 MINUTES OF THE MEETING HELD ON TUESDAY, 14th JULY 2020

It was **RESOLVED** that the Minutes of the Meeting of the Parish Council, held on **Tuesday 14th July 2020** be approved and signed without further amendment.

Matters Arising:

(1) Min 20/026(1) Kirkby Lonsdale Road Post Box.

It was noted that the collapsed wall had now been repaired. The Clerk advised that, despite repeated emails to the Royal Mail, no response had been received regarding the replacement of the post box.

(2) Min 20/033(3) Hedgerow Cutting

Councillor Metcalfe and the Chairman reported that they had personally trimmed the roadside hedge leading out of the village on the Nether Kellet Road. It was agreed that future arrangements needed to be agreed and finalised with the landowner.

Action: Councillor Metcalfe is to draft a letter to the landowner seeking to agree arrangements for the future trimming of the hedge.

20/038 DECLARATIONS OF INTEREST:

No changes were reported.

20/039 NEW PLANNING CONSULTATIONS

(1) The following planning applications were considered. It was resolved to respond as set out against each individual case.

- (2) **Development site adjacent to Greenways and Church Bank.** Further to the informal meeting held on 26th August 2020, the Parish Clerk confirmed that, following contact by Councillor May, the City Council had placed an emergency preservation order on the trees bordering the lane leading from the junction of Church Bank and Nether Kellet Road to the southern edge of the site. The Clerk had not yet received a response from the City Council to a letter questioning and expressing concern about the authority for activity on site. The Chairman reported that the fence erected on the site had been moved further out in the direction of the craggs but that the unofficial footpath below the craggs was still accessible. It was noted that the fencing had been knocked down at some points, though the cause of this was not known.
- (3) **Local Plan Green Spaces.** The Parish Clerk reported that, as agreed at the informal meeting on 26th August 2020, a letter had been sent to the City Council concerning the designation of the Craggs Green Space within the Local Plan and a response was awaited.
- (4) **Government Review of the Planning System**. Councillors referred to information recently received from LALC and agreed that some of the material could be usefully posted on the Parish Council's website. Following discussion, Councillors decided to accept the information and not submit comments to NALC on the current proposals.

Action: The Parish Clerk will post advice on the Government's review as a news item on the Parish Council website.

20/040 UPDATE ON PREVIOUS PLANNING APPLICATIONS

The Clerk presented a report updating the status of previous planning applications. The report was noted.

Councillor Johnson noted that the City Council's Conservation Team had now withdrawn its objections to the revised proposals for the erection of one dwelling on land adjacent to Woodlands View (application 20/00136/FUL).

20/041 PARISH PLAN

(1) SpID Data

The Clerk presented an analysis of data collected from the Kirkby Lonsdale Road SpID between 10th July and 3rd September 2020. Councillors agreed that the data was providing some very useful insights into traffic behaviour on the Kirkby Lonsdale Road and was beginning to reveal a number of trends which could be monitored and potentially raised with the Police and County Council in due course. The SpID had failed to report any data on several days during the period and it was agreed that this feature needed to be monitored and reported as a potential fault if necessary.

It was agreed that the Parish Council should continue to monitor and analyse the data with a view to developing any issues arising in a report to the Police and County Council following a reasonable period of data collection, six months being the suggested timescale.

(2) Goosegate Plaque

The Chairman reported that the plaque was on order and delivery was awaited.

20/042 ADJOURNMENT FOR PUBLIC DISCUSSION & INFORMATION ONLY UPDATES:

REPORTS FROM MEMBERS OF THE PUBLIC:

(1) **Kissing Gates**. Councillor Metcalfe reported that she had received a request from a resident that the Parish Council remove the kissing gate towards the northern end of footpath 1-24-FP9, which connects Kirkby Lonsdale Road with Nether Kellet Road. Following discussion, Councillors agreed that in the interests of safety, particularly with schoolchildren who use the footpath in mind, the kissing gates should be retained.

CLERK'S REPORT:

(2) Replacement of illegally removed trees. The Parish Clerk advised that he had received a letter from the resident who had initially reported the felling of the lime trees on the verge opposite Hall Garth Close, asking what progress was being made. It was agreed that the Clerk should write to the resident explaining the position. County Councillor Williamson had advised that the matter could now be picked up again with the City Council and County Council.

Agreed: The Clerk to write to the resident and to liaise with the Chairman to resume negotiations with the City and County Council regarding the replacement planting programme.

(3) **Heritage Walks**. The Chairman had placed a notice on the Parish Council notice board setting out details of a series of heritage walks in September, arranged by the Lancaster Canal Trust.
