24/028 Apologies For Absence

Apologies were received from Councillor Moody.

24/029 Minutes of the Annual Meeting of the Parish Council, held on Tuesday, 14th May 2024

Resolved: That the Minutes of the Annual Meeting of the Parish Council, held on Tuesday, 14th May 2024 be approved and signed without further amendment.

Matters Arising from the Minutes

- 1. Minute 24/019(1) Village Hall request for maintenance work. Nothing further to report
- 2. Minute 24/019(2) Post Box. Nothing further to report.
- **3. Minute 24/019(4) Footpaths.** Residents confirmed that the newly designated Sands Lane bridleway was inaccessible from the Kirk House end. Councillor Towers to investigate.
- 4. Minute 24/019(5) Local Delivery Scheme and Biodiversity Small Grants Scheme. Councillor Johnson had been in contact with the North Lancashire bat group, who had suggested a suitable supplier for the boxes.
- 5. Minute 24/019(8) Damaged road sign on Kellet Road. Councillor Johnson had reported the damaged sign again on the Love Clean Streets app, which was showing that the issue had been assessed and work was scheduled.
- 6. Minute 24/024 Insurance Policy 2024/25. A quotation had been obtained from Zurich Insurance for £327 (compared with renewal of £690). This had been accepted by the Clerk following consultation with the Chairman and Cllr Johnson. The Clerk has requested a valuation of the War Memorial and Stone Cross from a monumental mason business in Lancaster. The level of cover required will be pursued with Zurich Insurance if necessary.

- **7. Minute 24/025(1) The Millennium Stone.** Councillor Burns had attended to the cleaning of the Millennium Stone and repainting of the plaque.
- Minute 24/025(2) Hedge trimming on Maggie Eglin lane. No progress to report. Councillors Burns and Towers will inspect and attend to any necessary work.
- Minute 24/025(6) River Keer Catchment Water Quality Monitoring. The Chairman and Cllr Johnson are to attend a meeting at the Lune Rivers Trust offices at Newton near Arkholme.
- **10. Minute 24/025(12a) Eagles Head 'A' Board on The Village Green.** The 'A' Board has now been refurbished and the pub management have been informed of the permission to display the board on the Village Green.

3) Other Planning Matters

Redwell Inn – Self-Storage Containers.

County Councillor Williamson reported that enforcement action was being taken by Lancaster City Council regarding the storage containers themselves and the advertised business. No further information had been received about the camping pod proposals.

Road and Pavement Works on Kirkby Lonsdale Road.

This item referred to 'off-site' work associated with a S278 Highways Act order for planning application 17/01050/OUT (associated ref: 20/00405/REM) on the land north of Old Hall Farm on Kirkby Lonsdale Road in Over Kellet for the erection of up to 55 residential dwellings.

The Chairman gave a verbal update regarding the works and complaints received from residents regarding the removal of the cobbles. Following

correspondence with the City Council's Conservation Officer, queries about the work and any potential contravention of planning authority was in the hands of the Conservation Team and Planning Technical Team

Residents asked questions and expressed concerns about what had happened to the removed cobbles and safety aspects of the newly installed kerb.

Councillors agreed that the matters raised must be left with the City Council's Conservation Team and Technical Team for the time being and await their conclusions.

County Councillor Williamson suggested that for the future, Councillors might request the City Council to consult the Parish Council on and discharge of conditions (/DIS) applications.

Action: The Parish Council will await the conclusions of the City Council's Conservation and Planning Technical Teams.

24/032 Top Green, Over Kellet.

Councillors considered a proposal from a resident that, in recognition of the abundance and variety of orchids growing, the Parish Council should apply for Biological Heritage Site status for the Top Green. The resident's letter and information had been previously circulated.

Resolved: That an application for the Top Green to be designated as a Biological Heritage Site be submitted to Lancashire County Council. Councillor Johnson to liaise with the resident concerned in drawing up the application.

24/033 Consultations

a) Lancaster City Council – Local Plan Review – Open Space Assessment.

A public consultation and separate consultation with Parish Councils is being undertaken, with a deadline of 23rd June 2024. The Clerk advised that this was an opportunity for the community to seek the designation of the Church Bank Green as a Local Green Space.

1. Footpaths.

Residents and Councillors discussed the condition of various footpaths within the parish and agreed a range of actions

1. LALC.

Councillor Josie Candlin had attended the first Local Area Forum for several years, held on Wednesday, 22nd May at Morecambe Town Hall. Presentations had included Highways England and the County Council on product safety and reporting highways issues. The next meeting is scheduled for Wednesday,17th July at 7pm at Morecambe Town Hall, with the following meeting due in October.

2. Quarries.

Councillor Johnson reported that blasting was continuing, with reported levels well within limits. Clarification had been provided about a drawing displayed at the recent public presentation which indicated car and boat trailer parks. This was explained as a 'concept' drawing and any such developments would only be considered after closure of the working quarry and would be subject to a future environmental impact assessment.

3. Allotments. Josie

Councillor Josie Candlin reported that the Allotments Association had maintained contact with LESS following their recent district-wide study. The Parish Council's lease of the allotments was due for renewal in 2025. It has been suggested that, following renewal of the lease, the Association should require tenants to sign a formal agreement. There had been a recent meeting held about the outcomes of the LESS review and a report is expected.
